Norris Street Bridge and Riberolle Street Bridge update- Both are now complete with the exception of the footbridge installation at Riberolle Street. The Bid came in at \$318,163.35 and finished on budget.

Sewer Plant Ditch Maintenance project with Allstate Power Vac was completed under bid price. Bid price was \$90,900.00 and final is \$72,885.00.
