There are a few trees that should be considered for removal, one by Karschners and one by Ginn and Vickery.

PA DOT REQUEST: Pa Dot requested that the London Plane by the Post Office needs to be limbed up. Pete did limb it up as far as he could. It will have to get bigger to do any more pruning.

REPLANTING MAIN STREET: Peter will order 4 Elms for November planting. The other trees that were ordered are from the Tree Vitalize Grant and need to be planted this fall. A motion was made by Scott Nichols to remove the two Sophoras on Main Street and put in fresh dirt in the holes and was 2<sup>nd</sup> by Brian Kennedy.

PERMITS: Glenn & Linda McNeill for 153 Main Street – prune according to specs.

A motion was made by Scott Nichols to accept permits and Peter Herres 2<sup>nd</sup>.

WATERING: They will continue to monitor the trees and will water if needed.
